## 6. Planning / Ceisiadau Cynllunio

16/0442/PA Proposed extension, Arfryn

The Community Council supported the application but requested that access to and through PROW 87/52 be kept open at all times during the works, should permission be granted, including consideration of parking arrangements for vehicles associated with the build.

16/0484/PA Erection of one new dwelling (in retrospect), Cam yr Afon, Penrhiw

St Dogmaels Community Council supported the application provided that it was of the same scale and overall design as the previous application (13/0950/PA) approved on the site.

16/0450/PA Proposed boat shed with sail loft above, site to the east of Dwylan, Poppit

St Dogmaels Community Council did not support the application on the following grounds:

The Council believed that the proposed application was outside the village envelope and would set a dangerous precedent if approved. The scale and design of the building was totally out of keeping with the area of the village and was also inappropriate, on those grounds, to be sited at the entrance to the village. Local knowledge suggested that the area did flood, particularly as the bank was eroding in the area of and adjacent to the proposed site. The Council objected to any proposal to connect to the mains sewers as the sewer infrastructure in the village was already inadequate for its current load. The Council was concerned that development on the proposed site might impact on designs for the proposed 'Route to Poppit'. The Council requested that, should permission be given, that a condition be put upon the building that it would be used solely for the purpose of storing boats and equipment associated with storage of boats.

Complaint re jet/water ski noise

Both the County Cllr and Clerk had been researching who might be responsible for enforcing appropriate use of jet and water skis on the river. Both felt that Afon Teifi Fairways Ltd would be the responsible authority. The Clerk had already contact ATFL and would circulate a response when received.

Concern was also expressed that the slipway in Cardigan appeared to have been closed off leaving the slipway at Glanteifion as the only option on the 'St Dogmeals' bank on the lower reaches of the river. Given the problems with traffic through the village it was agreed that the Clerk contact ATFL to enquire as to why the Cardigan slipway had been closed.

# 8. Cllrs Exchange of Information / Cyfnewid Gwybodaeth

The Chairman also suggested that alternatives be looked at with regard to the High Street Car Park, possibly some kind of arrangement whereby the Community Council took over the amenity. CC M James suggested that if the car park were to be under Community Council control then it was likely that the toilet block would be transferred with

it. Cllr G Wislocka expressed concern that the culverts that drained from the landslip area ran under the car park and if the Community Council were to take possession of the car park then these would become the responsibility of the Community Council.
