*Minutes of the Flooding and Impacts Committee which met on 7<sup>th</sup> February 2019 at 7pm at Y Neuadd Goffa, Maeshyfyrd, St. Dogmaels*

**2. Election of Chairman**

Cllr F Coates was elected as Chairman.

**4. Confirmation of Order of the Agenda**

**5. Work Already Undertaken**

The committee reviewed the work in progress from previous meetings re landownership, mapping the catchment area, recording flooding incidents and conversations with riparian landowners.

The site visit by Dr Xavier of Swansea University, Mair Rees NRW, Anthony Rogers Pembrokeshire Biodiversity Partnership, Trevor Theobald PCC Ecologist on 25<sup>th</sup> Jan was noted with thanks. The possibility of getting a Masters student from Swansea University to assist with a topographical study and assess whether flood mitigation measures such as leaky dams may be useful was discussed.

The Committee understood that maintenance of the Briscwm stream banks was not within the Community Council's Duties or Powers. The Committee did not wish to recommend that the Council take on an unquantifiable risk on which it had no powers to spend funds.

**6. Work to Take Forward**

**Short term:**

- i. Identify Base Flows in woodlands with photos
- ii. Photo Peak flows in heavy rain at Awel y Mor Culvert & Briscwm stream
- iii. Possibly Purchase flow meters & measure flow from Awel y Mor culvert and Briscwm stream (awaiting advice from Dr Xavier)

*Proposals:* The Committee proposed to ask the Community Council to request PCC supply :

- A. More information about the culverting of water from the Awel y Mor Development Site into the Briscwm Stream
- B. PCC's Local Flood Risk Management Strategy and all the relevant policy documents with respect to surface water, river & stream management and flooding
- C. Assistance to develop a 'Flood Event Action Plan'
- D. Relevant topographical & geomorphology information on the Briscwm Stream from Emyr Williams

*The Committee also proposed:*

- E. To ask the Community Council to link the flooding issue with PLANED's Community Well Being & Resilience Project Pembrokeshire
- F. The Community Council considers developing a Place Plan that meets needs of St Dogmaels that incorporates the issues of Flooding and Sewage Capacity? (There is a Place Plan training in Carmarthen on 1<sup>st</sup> May)
